RELEASE

Participant shall defend, indemnify and hold Event Organizers harmless from and against any and all claims, demands, losses, suits and expenses relating to this Release and Authorization arising out of Participant's actions or negligence.

RULES AND REGULATIONS

Participant agrees that he/she and all persons attending this event with Participant, whether as spectators, competitors, officials or guests are obligated to adhere to the "Official Rules." CANCELLATION & REFUND POLICY

The deadline for a refund on a cancellation is 30 days prior to the date the competition commences. Refunds will be made by mail, 30 days following the completion of the competition. If the Organizer is notified of cancellations after the deadline, credit toward the following year will be considered in cases of emergency only and must accompany a Doctor's Certificate. There will be a minimum \$50 service charge, per participant, for cancellations. No substitutions will be allowed for entry cancellations at the event. AUTHORIZATION
